IOWA STATEWIDE POISON CONTROL CENTER (ISPCC) PROVIDES IOWA'S 3.0 MILLION RESIDENTS 24-HOUR TOLL-FREE TELEPHONE ACCESS TO EMERGENCY POISON INFORMATION AND TREATMENT ADVICE FROM SPECIALLY TRAINED NURSES, PHARMACISTS AND PHYSICIAN TOXICOLOGISTS. THE ISPCC CAN ASSIST PEOPLE OF ALL LANGUAGES AND THE HEARING IMPAIRED. DURING THE FISCAL YEAR 2016-17, THE ISPCC RESPONDED TO 32,652 CALLS, INCLUDING 26,262 HUMAN EXPOSURES TO POISONOUS SUBSTANCES AND 6,390 CALLS FOR REQUESTS INVOLVING DRUG IDENTIFICATION, ANIMAL POISONINGS, OR OTHER INFORMATION CALLS.
