IOWA STATEWIDE POISON CONTROL CENTER (ISPCC) PROVIDES IOWA'S 3.0 MILLION RESIDENTS 24-HOUR TOLL-FREE TELEPHONE ACCESS TO EMERGENCY POISON INFORMATION AND TREATMENT ADVICE FROM SPECIALLY TRAINED NURSES, PHARMACISTS AND PHYSICIAN TOXICOLOGISTS. THE ISPCC CAN ASSIST PEOPLE OF ALL LANGUAGES AND THE HEARING IMPAIRED. DURING THE FISCAL YEAR 2018-19, THE ISPCC HANDLED 25,651 HUMAN EXPOSURE CASES AND 3,831 REQUESTS FOR INFORMATION INCLUDING PILL IDENTIFICATION, DRUG INFORMATION, ANIMAL POISONINGS, OR OTHER INFORMATION ABOUT POISONS OR POISON PREVENTION.
